### **Membership Categories and Dues**

All membership dues include the cost of bi-monthly meetings.

**Governmental:** A Governmental Member shall consist of a governmental unit, department or agency engaged in the administration, formation, or enforcement of laws, ordinances, rules or regulations relating to the public health, safety, and welfare in the built environment. Each Governmental Member shall be entitled to the number of voting representatives specified below. Governmental Member Representatives shall be designated in writing at the time of application and shall be employees or officials of the Governmental Member as stated above.

#### **Annual Dues and Voting Representatives are based on Population:**

0 to 75,000	\$100.00	Two (2) Voting Representatives
More than 75,000	\$200.00	Four (4) Voting Representatives

**Individual Governmental Member:** An Individual Governmental Member shall consist of a current employee for a municipality, county, or state agency. Each Individual Governmental Member is allowed one (1) voting representative, which shall be designated in writing at the time of application. **Dues:** \$50.00

**Agency Membership:** An Agency shall consist of a governmental agency involved with the administration of building, land use, and other related development codes of any political subdivision or municipality. Each Agency Membership is allowed one (1) voting representative, which shall be designated in writing at the time of application. **Dues:** \$50.00

**Corporate Membership:** A Corporate Membership shall consist of an organization such as, an association, society, testing laboratory, institute, university, college, company, manufacturer, or corporation interested in the purposes and objectives of the Chapter. Each Corporate Member is allowed one (1) voting representative, which shall be designated in writing at the time of application. **Dues:** \$50.00

**Courtesy Membership:** Courtesy membership is extended to the MBPTA's ICC (International Code Council) Liaison with no annual or meeting dues. There will be no voting privileges for this membership.

**Special Membership:** Special Membership consists of any other application for membership that is not covered by Article III, Section 2 of the By-laws, and must be considered a special case and so handled by vote of the Executive Board. (Please attach a description of your position and the company you work for). Each Special Membership is allowed one (1) voting representative, which shall be designated in writing at the time of application. **Dues:** \$50.00
