#### **Membership Categories and Dues Schedule**

<u>Governmental Membership</u>: A *Governmental Membership* consists of a governmental unit or a municipal department that is engaged in the administration, formation, or enforcement of laws, ordinances, rules or regulations that relate to public health, safety, and welfare in the built environment. Each *Governmental Membership* includes the number of voting representatives specified below. *Governmental Membership Representatives* shall be designated in writing at the time of application and shall be employees or officials of the unit or of the department as described above.

<u>Agency Membership</u>: An *Agency Membership* consists of a governmental agency — **not a municipality** — that is involved with the administration of building, land use, and/or other related development codes of a political subdivision or municipality. (Examples of Agencies: Soil and Water Conservation District Office, DNR, MPCA.) Each *Agency Membership* includes one (1) voting representative. The *Agency Representative* shall be designated in writing at the time of application. **Annual Dues: \$100.00.** 

<u>Corporate Membership</u>: A *Corporate Membership* consists of an organization such as an association, a society, a testing laboratory, an institute, a university, a college, a company, a manufacturer, or a corporation interested in the purposes and objectives of the Chapter. Each *Corporate Membership* includes one (1) voting representative. The *Corporate Representative* shall be designated in writing at the time of application. **Annual Dues: \$100.00.** 

<u>Courtesy Membership</u>: A *Courtesy Membership* is extended to the MBPTA's ICC (International Code Council) Liaison with no annual or meeting dues. A *Courtesy Membership* has no voting privileges. **No Annual Dues**.

**Special Membership**: A *Special Membership* consists of any other membership that is not covered here and must be considered a special case and be handled by vote of the Executive Board. In making application for a *Special Membership*, please attach a description of your position and of the company you work for; also state your reason(s) for and your interest in MBPTA membership. Each *Special Membership* is allowed one (1) voting representative. The *Special Representative* shall be designated in writing at the time of application. **Annual Dues: \$50.00**.
